



## NAUI Board of Directors Election Nominee Application

### Instructions

1. Any NAUI member who is interested in running for election to the NAUI Board of Directors must complete and sign the Nominee Application form. The NAUI member must be qualified to run for election per the requirements in the NAUI Bylaws.
2. All questions and fields on the Nominee Application Form must be completed in order for the nominee to be considered for the ballot.
3. The nominee will identify 5-10 NAUI members to endorse him or her. He or she will provide his or her signed Nominee Application Form and a blank Nominee Endorsement Form to each of those individuals. There are several criteria for any individual providing an endorsement:
  - The individual must be qualified to vote as of the date the nomination application is signed.
  - The individual must receive, read, and support the nominee's signed application.
  - In a single year the individual cannot endorse more nominees than the number of Board seats to be filled by the election scheduled for that year.
4. The nominee will collect the signed endorsement forms. The signed endorsements may be scanned images.
5. The nominee will send the signed Nominee Application Form and signed Nominee Endorsement Forms to the Elections Committee per instructions provided in the announcements for "Call for Nominations."
